"What Matters in the End" Speakers: Rev. Marcia Schekel & Sue Curry, RN

Marcia Schekel, an ordained Unitarian Universalist minister and retired hospice chaplain, and Susan Curry, RN, Hospice Nurse and Manager for Bridges


Palliative Care Hospice Southwest. They will discuss, "What Matters in the End." Lorraine Wheeler and Nancy Stepsis will serve as moderators.

Modern medicine has advanced dramatically in the past century. Average life expectancy has increased from the mid-40s to the mid-70s today. But as medicine has advanced and people are living longer, children are more likely to live far away from aging parents. Nursing homes and assisted living facilities are popular destinations, but often focus on safety and routines at the expense of quality of life and human interaction. Harvard physician and author Atul Gawande argues that making mortality a medical experience is failing society and that end-of-life treatments often end up shortening lives instead of extending them. What does an effective healthcare system look like in the 21st century?

The panel discussion will be based on some of

the end-of-life issues covered in Atul Gawande's book *Being Mortal: Medicine and What Happens in the End.* In his book, Dr. Gawande explains that medical practice and philosophy have not kept pace with the changes in healthcare over the last 100 years. To derive extra benefit from the panel discussion, AAUW members are encouraged to read Dr. Gawande's book.

In *Being Mortal*, Atul Gawande tackles how medicine can not only improve life but also the process of its ending.

Global Concerns April 26 1 p.m. Genealogical Center Speaker Ann Bardacke: Inside & Outside Humanitarian Programs



Ann Bardacke has been traveling to Israel to provide humanitarian and educational assistance for over twelve years. She will describe the various programs sponsored by the Women's Courtyard Program and explain her involvement with them when she speaks for The Global Concerns Interest Group on April 26. She has been connected to the Women's Courtyard Program, providing education, training and support to lower income women in the city of Kiryat Malachi since 2003 when she spent a month there teaching conversational English in one of the high schools.

Ann will also share some of her experiences teaching in elementary schools, high schools and even one Arab school in Jaffa. She can explain the programs sponsored by the Jewish Federation of Greater Portland and answer questions about other humanitarian projects she has supported.

Ann Bardacke "There are lower-income Israelis who are in need of social and educational support and that is where I have focused my efforts," she said.

Ann earned her BA from The City College of New York and her MA from California-Berkeley in sociology. She taught at the Community College level, worked as a health planner, administrated a Federal Employees program for an HMO in Washington, D.C, worked in Alaska for an Early Intervention Program and eventually joined her husband in his investment business here in the Northwest. Ann travels to Israel almost every year, but has also visited in Europe, Mexico, Argentina, Japan and India as well as Canada and the United States.


The gender pay gap is a premier issue for AAUW and one that the organization has been working on for a long time. As early as 1922, AAUW's legislative program called for a reclassification of the U.S. Civil Service and for a repeal of salary restrictions in the Women's Bureau. In 1955, AAUW supported a bill introduced by Reps. Edith Green (D-OR) and Edith Rogers (R-MA) requiring "equal pay for work of comparable value requiring comparable skills." Congress enacted the Equal Pay Act, a version of the 1955 bill, in 1963.

Despite the Equal Pay Act, the wage gap persists; women are typically paid just 79 cents on average for every dollar paid to men, and that number has barely budged in a decade. Although enforcement of the Equal Pay Act, as well as of other civil rights laws, has helped to narrow the wage gap, significant disparities remain to be addressed.

For these reasons, AAUW advocates for the Paycheck Fairness Act, which would improve the scope of the Equal Pay Act with stronger incentives for employers to follow the law, enhance federal enforcement efforts, and prohibit retaliation against workers asking about wage practices. To draw attention to the gender pay gap and build support to pass the Paycheck Fairness Act, AAUW observes Equal Pay Day.

Think 79 cents is bad? The pay gap is even worse for women of color. AAUW also observes Asian American Women's Equal Pay Day in March, African American Women's Equal Pay Day in August, Native American Women's Equal Pay Day in September, and Latina Equal Pay Day in October.

It is my turn to write this month's president's column, so I have decided to write one big editorial to cover both assignments. Thanks for your indulgence and here goes...

The first thing on my mind is to share some thoughts about the value of the college scholarships that our branch provides each year to women going to colleges in our area. For 2016-2017, the board has approved two \$2500 scholarships for women attending WSU-V. This is only possible because of donations and the dedicated work done by our branch members to solicit gift cards from local businesses for our holiday fundraiser. Those efforts can make a truly significant difference in a young woman's life.

Students drop out of college for many reasons, of course, but the number-one reason students cite for having to quit is the need to work while attending school. As costs skyrocket, it's becoming impossible to pay for college without working, but long work hours make it harder and harder to devote time to classes. Student loans provide one alternative to pay for school without having to work full-time, but they come with their own drawbacks. According to the Institute for College Access and Success, the average student loan borrower graduates with \$29,400 in student loan debt and the nation's total

student debt load passed \$1 trillion for the first time last year. That's \$200 billion more than our country's total credit card debt! In 2013, for the first time, grants and scholarships became the single biggest way students paid their tuition and fees. Sallie Mae's "How America Pays for College" study revealed that 30 percent of college costs are being covered by grants and scholarships, with parental borrowing taking care of 28 percent. According to the report, these forms of financial aid have assumed a post-recession importance that doesn't look like it will change. The post-recession reality appears to be that grants and scholarships have replaced parent income and savings as the major contributor to paying for college.

On the subject of our scholarships, your AAUW Board of Directors has been asked to review the criteria for awarding AAUW scholarships at WSU. If you would take the time to give us your input, by filling out the survey on the next page, it would be greatly appreciated. Just bring it to the next meeting or mail it to Connie Egeler, scholarship chair.

The 17 women who were busy founding our branch 85-years-ago would be proud of us... I know I am!


