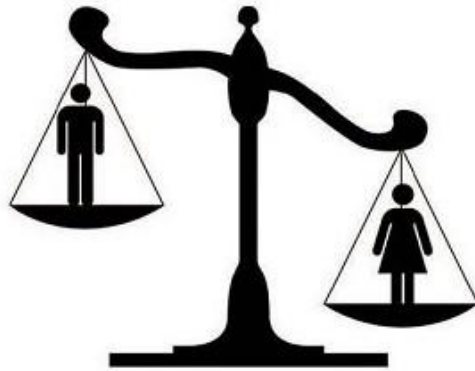

## Judge Virginia Mellema MaGee: Gender Discrimination in Employment

AAUW’s February 11 general meeting will begin at 10 a.m. in the community room at Pacific Continental Bank at 101 Sixth Street in Vancouver. The February program will highlight gender discrimination in the workplace.

Our speaker is Judge Virginia Mellema MaGee who will address Federal employment law as it relates to gender discrimination. Judge MaGee has been a Federal EEOC judge in San Francisco since 1992.

Judge MaGee will discuss examples of gender discrimination and the legal remedies available to employees. She will cover topics such as gender pay equity; women being penalized for not being “nice;” and the increasing realization that, in sexual harassment cases, current law focuses on liability-based remedies instead of fixes to our culture.

### 2016 Holiday Brunch Fundraiser Yields \$2561

The 2016 Holiday Brunch & Auction on December 10, was very successful. The event netted our highest amount since 2013. The fundraiser, chaired by Pat Greear, was attended by 59 people and yielded a profit of \$2561.04, including a \$100 donation to our scholarship fund at CFSW and several other donations equaling \$80.

For the auction, AAUW branch members solicited gift cards from local businesses and also gave new items they had made or received. The donor recognition page in this publication displays the business donor logos, which represent the efforts of 11 individual members. AAUW also bought small evergreen trees from Yard and Garden Land at cost and sold them for \$12 each. The \$1 raffle offered winners their choice of 19 donated prizes and earned \$326, an increase of \$87 over last year. 2016 offered a bake sale again, which netted \$224, twice as much as was earned at our last bake sale in 2013. Congratulations to the committee and members who worked to make this a success!

- ★ We celebrated **44** years of Title IX with Sen. Harry Reid.
- ★ Members organized more than **900** get-out-the-vote events in **46** states.
- ★ **19** AAUW members were elected to state legislatures.
- ★ **12** AAUW delegates attended the White House United State of Women Summit.
- ★ *AAUW in the Statehouse* newsletter launched with **1,767** subscribers.
- ★ Members hosted more than **200** Equal Pay Day events nationwide.
- ★ AAUW was **1** of **55** industry-wide Power of A Award winners.
- ★ **2,786** Lobby Corps meetings were held with congressional staff.

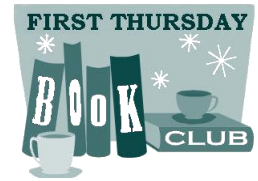

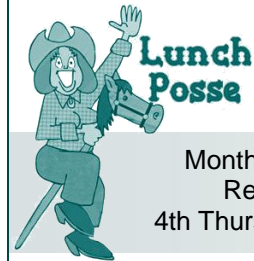


