

AAUW Vancouver's January general meeting will be held Saturday, January 12, at 10 a.m. in the community room at Columbia Bank, 101 Sixth Street, Vancouver. The meeting will feature a presentation by Helen Elder of Villages Clark County.

Villages Clark County is part of a national village movement to help seniors stay living in their homes. There are more than 200 villages open throughout the US and more than 40,000 members. Villages Clark County is part of Portland Villages NW where six villages are open. Villages Clark County will be open in February 2019 to provide services to seniors who join.


Villages Clark County is creating a community, a support system for seniors who have lost theirs and become isolated, i.e. their spouse is gone, grown children have moved and best friend is in assisted living. Who do they turn to for a little help? A neighbor who becomes a background checked, trained volunteer. Volunteers help seniors with a ride to a doctor's appointment, a little help around the house, with yard work, errands and companionship.

"One Call Does It All" provides seniors with the confidence in their decision to stay in their homes knowing that a neighbor is just a phone call away.

Those interested in volunteering can attend a short volunteer training session held monthly and posted on the Villages website www.VillagesClarkCounty.org, Facebook, Meetup, and in our newsletter or they can call the office at 360-553-1520 for more information. Seniors in-

terested in becoming members can call the office number and leave a message or email their contact information to infovillagescc@gmail.com.

Helen was one of the original Villages Clark County volunteers when it started forming as an organization more than three years ago. She currently serves as Chairperson of the Steering Committee in addition to other work with marketing, publicity, outreach, membership, volunteer coordination, and community building. Helen is a retired city planner and lives outside of Washougal on a small organic farm with her husband Jay and her other favorite hiking companion, a border collie named Wesley.









As many of you know, Kitty Welsh passed away on October 15<sup>th</sup>. She had been fighting cancer for several years, but it was a shock to many of us to hear that she was gone. Nine members of our branch took Kitty to lunch in August and she seemed to really enjoy the outing, as did we all.

Kitty was a good friend to many of us individually and a great friend of our AAUW branch. Her first donation of \$10,000 was the impetus to open our scholarship fund at the Community Foundation. The balance of that fund is now close to \$150,000. Kitty believed in our goals and objectives and, as a result, her generosity will continue to help us award college scholarships to local young women for many years to come.

I met Kitty in February 2010 when we had lunch at Ruby Tuesday and I interviewed her for the article reprinted below. She was that first day - as always - such fun to be with.

Kitty Welsh, nee Kathryn Lance, was born and raised in Montpelier, Vermont. Her father owned a sporting goods store there and another in Canada. Kitty attended Middlebury College and met her first husband at an ice skating rink in Norwich, though they didn't begin dating until 2 years later when they ran into each other at a hockey game. Her husband was in the Army and spent 18 months in the South Pacific during the Korean War. When he returned home, the Army transferred him to Anniston, Alabama where he and Kitty became the proud parents of their daughter Tracy. Leaving the Army, Kitty's husband went to work for

**Kitty Welsh** proud parents of their daughter Tracy. Leaving the Army, Kitty's husband went to work for the Atomic Energy Commission, which moved them to Germantown, Maryland. Eventually Kitty's husband began teaching at Duke University and the family relocated to Chapel Hill, North Carolina.

Kitty did lots of volunteer work over the years including working to help establish a library at her daughter's school and working as an aide in the school nurse's office. Her career also included some fascinating paid jobs. For example, she worked for a small newspaper in Palm Beach, Florida and interviewed Skitch Henderson and his wife Ruth as well as Bob Greene, the radio and TV personality who married Anita Bryant. Kitty confided that she was the ghost writer for some of Green's love letters to Bryant. She also taught dancing at the Fred Astaire Dance Studio in Palm Beach and worked for the Department of Labor's Bureau of Labor Statistics while in Durham, North Carolina. Later, Kitty was co-owner of a boutique-style furniture and jewelry store in Durham called La Renaissance.

After 33 years of marriage, Kitty and her first husband divorced and Kitty went to work for DUPAC (Duke University Preventive Approach to Cardiology). It was on the track at DUPAC that Kitty met her second husband, Paul Welsh, who was a professor of Philosophy at Duke and an author. They were married until Paul's death in 2005.

We are fortunate that Kitty's daughter, Tracy Packard, and her husband Jim live in Vancouver because that is why Kitty moved here 3 years ago. Tracy's husband is an agent with the Treasury Department, now part of Homeland Security. They have two sons, Zachary 22 and Michael 19.

Kitty is part of our AAUW Bridge Group and has given generously not only to our organization, but the whole community. This December she donated \$10,000 to our AAUW Vancouver Branch to further the education of young women at WSU and other local educational institutions. For the last three years, she has also given a scholarship to Clark College for women aspiring to be nurses or dental technicians. In addition, she is currently building a park at the college that will include a playground, herb garden, and hands-on activities for children.


